### **Chairperson:**

1. To supervise and monitor overall activities of IQAC.
2. To prepare annual plan of committee.
3. Approve minutes of the meeting.
4. Conducting the meeting and making decisions for the committee.
5. Approval authority of the SOPs.

### **Secretary(co-ordinator) :**

1. To co-ordinate the functions and activities of SOPs
2. To prepare annual AQAR report
3. Ensure the adherence of functioning of IQAC activities as per the SOPs.
4. Maintaining all the documents related to activities of IQAC
5. Preparation of the agenda of the meeting and scheduling minutes of the meeting
6. Assist and co-ordinate with Chairperson in activities related to IQAC
7. Revising SOPs as per the requirement

### **Members :**

1. To attend all the meetings of IQAC
2. To actively participate in the activities of IQAC and preparation of AQAR report.



## Note

- It helps the institutions in planning and monitoring.
- IQAC will give stakeholders or beneficiaries a cross-sectional participation in the institution's quality enhancement activities.
- The membership of such nominated members shall be for a period of two years.
- The IQAC should meet at least once in every quarter.
- The quorum for the meeting shall be two-third of the total number of members.
- The agenda, minutes and Action Taken Reports are to be documented with official signatures and maintained electronically in a retrievable format.
- It is necessary for the members of the IQAC to shoulder the responsibilities of generating and promoting awareness in the institution and to devote time for working out the procedural details. While selecting these members several precautions need to be taken.
