## **REPORT ON WEBINAR**

### **1. INTRODUCTION**

The Department of Community Health Nursing at Godavari College of Nursing, Jalgaon, organized an enlightening and academically enriching webinar on 2nd July 2025 titled "The Impact of Policy Changes on Community Health: Recent Legislation and its Effects." The webinar was conceptualized in response to the ongoing transformation in health policies at national and global levels, especially post-pandemic, which calls for continuous upskilling of nursing professionals in policy analysis and its practical implications.

The initiative aimed to provide students and nursing faculty with updated knowledge and insights into how policy reforms and legislative actions shape the delivery of healthcare services, influence the accessibility of healthcare facilities, and impact the professional roles of nurses within the community setting.

### **2. OBJECTIVE OF THE WEBINAR**

- ❖ To enhance understanding of recent legislative changes related to public health in India.
- ❖ To assess the impact of these policy changes on community-based healthcare practices.
- ❖ To empower nursing students and faculty with policy-oriented knowledge to become effective advocates for health reforms.
- ❖ To bridge the gap between health policies and grassroots implementation through professional engagement and awareness.

### **3. GUEST SPEAKER PROFILE:**

The keynote speaker for the session was Ms. Priya DadaraoJadhao, a distinguished professional in the field of Community Health Nursing.

#### **4. SESSION OVERVIEW:**

Ms. Jadhao opened the session by emphasizing the dynamic nature of health systems and how legislative decisions form the backbone of community health interventions. She gave a well-structured presentation highlighting:

- The evolution of national health policies, including Ayushman Bharat, National Health Policy 2017, and recent acts impacting rural and urban health infrastructure.
- The effect of laws and reforms on healthcare accessibility, resource distribution, and equity in health services.
- The role of community health nurses in interpreting and implementing policies in day-to-day practice.
- Real-time case examples illustrating the challenges and success stories of policy enactment at the grassroots level.

The speaker elaborated on how nurses are not just care providers but also policy implementers, educators, and advocates, and therefore, staying updated with evolving legislation is a professional necessity.

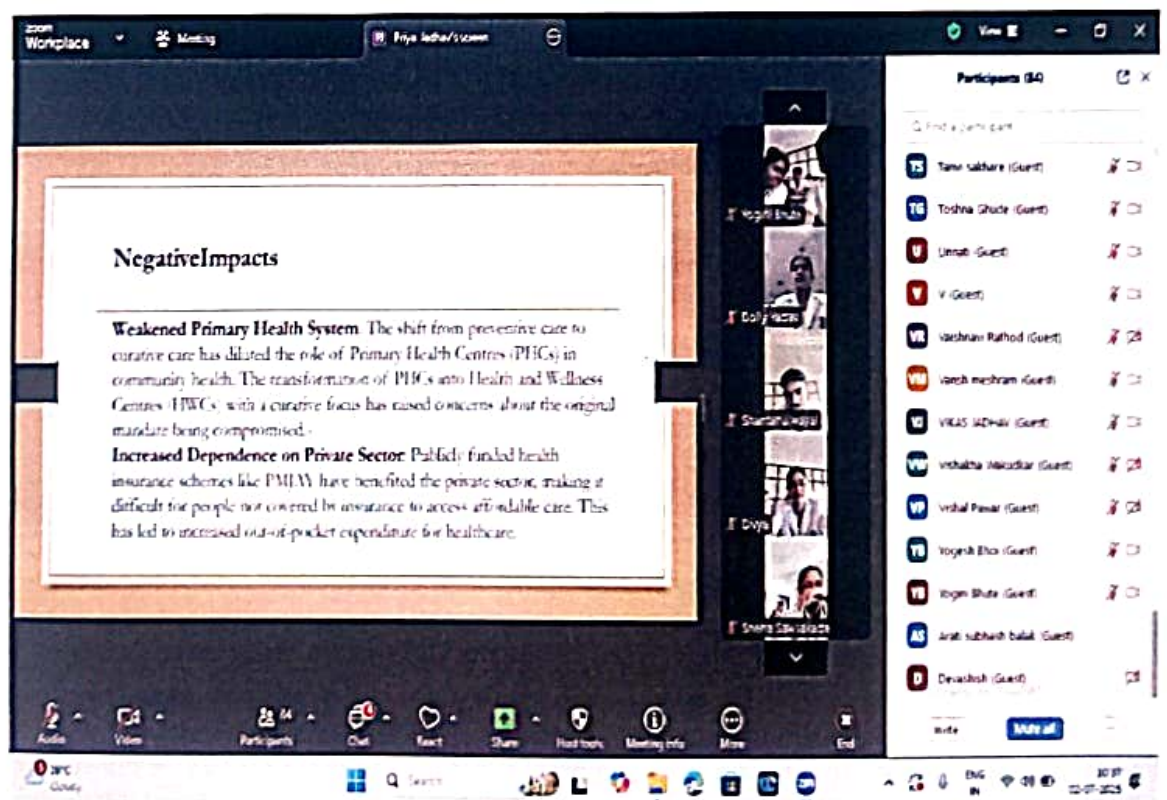
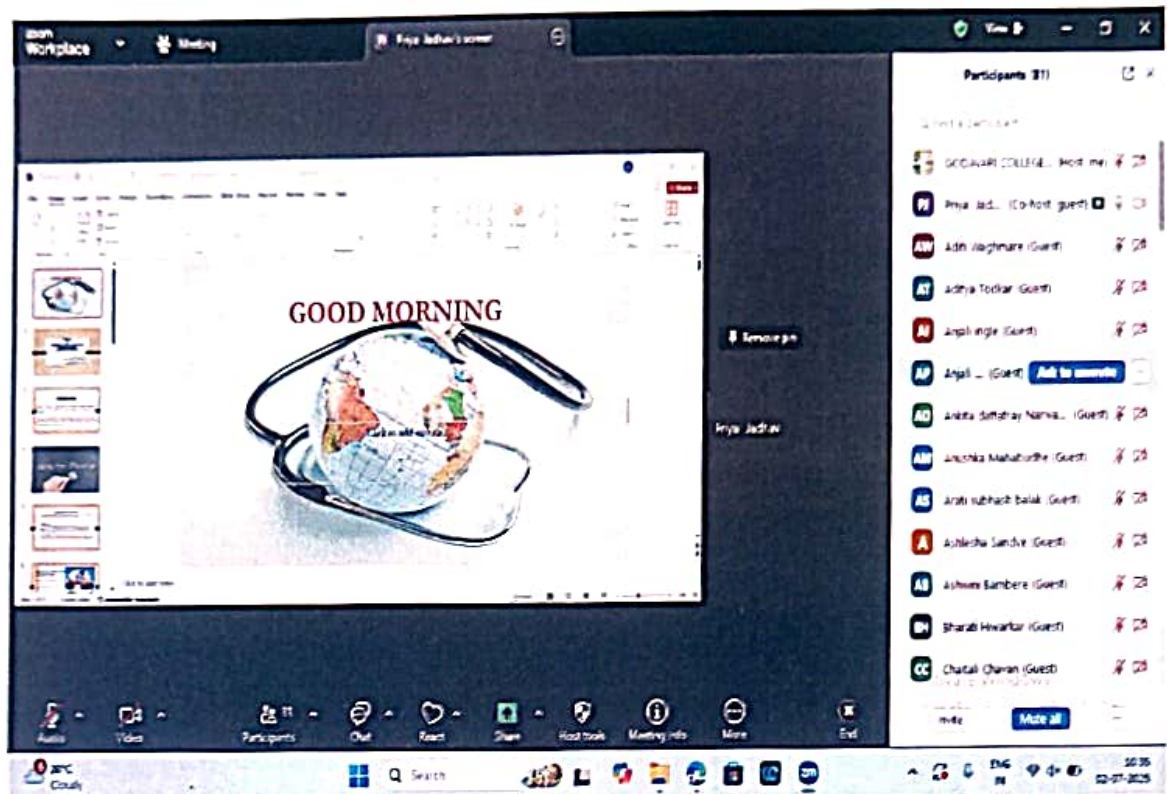
